1. This is an informal notice that the next Annual General Meeting of the Wellington Model Aeroplane Club will take place on Wednesday, 31st March 2010, starting at 8.00pm at Belmont Memorial Hall.

2. Notices of Motion: If you want to forward any notices of motion, these should be in my hands by no later than Wednesday, 17th March 2010.

3. Committee nominations: All members of the current Committee are required to retire at the forthcoming Annual General Meeting. These retiring members, however, remain eligible for nomination for any Committee position, but on exactly the same footing as any other WMAC financial member. There are eight Committee positions. The Committee positions are President, Secretary, Treasurer, Recording Officer and Club Captain. In addition, there are three (3) "ordinary" members elected at the AGM. The Committee itself appoints the Bulletin Editor/Webmaster, almost always from one of these three.

Committee Nominations should be in my hands not later than Wednesday 24th March 2010. You may send them using either email or ordinary post.

If you are using ordinary mail, please send your nomination(s) and/or notices of motion to me at the address above, using the form on the page following.

If you are using email, the model on page 3 illustrates the recommended method of sending your nominations. Reading from the bottom of the example email to the top: "Proposer" sends "Seconder" a message nominating "Nominee" for a specified position on the Committee; "Seconder" forwards that message, with the addition of his statement seconding that nomination, to "Nominee"; finally, "Nominee" forwards that composite message, with the addition of his statement that he accepts nomination, to me. Please use your real names, not email aliases, to sign your messages

4. I will send out formal notice of the AGM, including all relevant documents (e.g. Agenda, Minutes of the previous AGM, Officers' Reports, &c.) by email and post them on the club website. Expect these on or before 17th March 2010.

5. If you have any questions about the content or conduct of WMAC AGMs, please do not hesitate to ask them of me or any other member of the current Committee.
